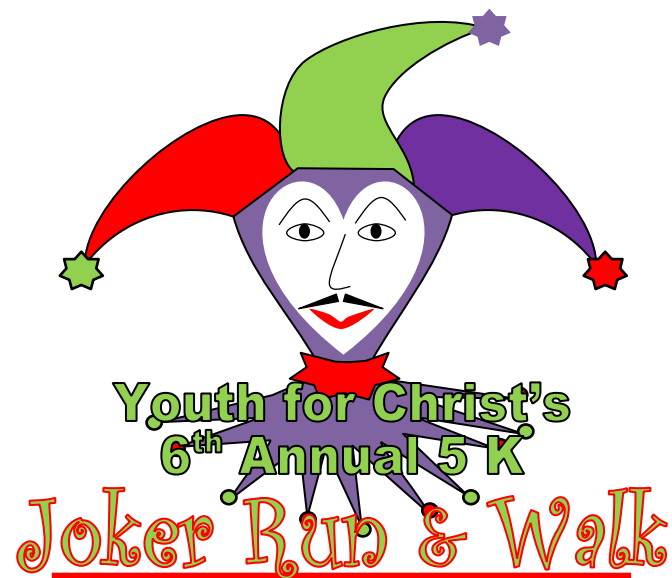

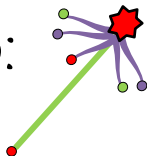

THE JOKER RUN: RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT ("AGREEMENT")

In consideration of being permitted to participate in **The Joker Run** conducted by Susquehanna Valley Youth for Christ, Inc. D/B/A Central New York Youth for Christ the undersigned "RELEASOR" represents that the Participant understands the nature of the Activity and that the Participant is qualified, in good health, and in proper physical condition to participate in such Activity. I understand that if I am pregnant and participate I could cause harm to come to my unborn child. _____ (initial here)
